THE CHALLENGE

There are nearly 2 million care workers in the UK looking after some of the most vulnerable people in our society. Faced with an already mentally and physically demanding role, it is no secret that this dedicated and selfless workforce can also struggle with low pay, staff shortages and limited access to training. Until now, these committed individuals have had little access to the support they deserve when facing financial hardship. This is where The Care Workers Charity proudly aims to make a difference.

Take Lauren for example, who had to reduce her hours as a care worker after fleeing domestic violence with her son and move into an unfurnished property. With nothing in savings, Lauren explained to us that she felt “failed and let down after approaching the local authority for help”, but approaching our charity gave her hope in her time of need. To ensure Lauren could live independently, we awarded her a grant to pay for a cooker and carpets to help build a home that Lauren now describes as “a safe place and a castle that my son and I have so much pride in”.



OUR CHAMPIONS

Champions are our eyes and ears on the ground. They lead on fundraising in their local community, raise the profile of our cause and sign post colleagues experiencing hardship to our grant giving service.

Becoming a Champion means joining a huge network of supporters across various care providers and suppliers. Working together through fundraising initiatives and awareness campaigns Champions help us to get closer to our vision, where no care worker in the UK faces financial hardship alone.
